

Board Briefs from School Board Meeting Feb. 22, 2021

Board Briefs are a communication tool designed to highlight important conversations and decisions made on behalf of students, families, staff, and the larger community by the District 70 School Board at each monthly School Board meeting.

Full-Day Reopening Update

At the Feb. 22 Board of Education meeting, Supt. Matt Barbini recommended the following option to the school board and it was approved in a 5-2 vote:

- Elementary
 - Beginning on April 12, 2021, provide full-day instruction to in-person students K-5 by socially distancing as much as possible. Most classrooms will have students seated less than six feet away from each other;
 - Elementary students already are in "pods" with their teacher for most of the day. Contact tracing and quarantines due to close contact will likely only impact that classroom;
 - Student and teacher assignments will change.
- Middle School
 - Implement hybrid version 2.0 with live-streaming and two full days of inperson instruction for cohort A and B (AA Deep Clean/Remote and BB)
 beginning on March 8; Middle school students are not in "pods" and move throughout the day. The schedule can be found <u>here</u> (item 6.2, presentation, on the agenda).
 - Staying in hybrid reduces the likelihood of quarantining large groups of students (a whole team, grade level, or all of HMS).

• Families will continue to have a choice of having their child(ren) attend in-person or virtual in both the elementary and middle school levels.

Highland Live-streaming Overview

An overview was shared during this Board meeting regarding the process to prepare for and support live streaming instruction at Highland Middle School. This will lead to an increase in instructional time for all students (virtual and in-person).

BinaxNow

Desk Shield Purchases

The school board approved the emergency purchase of transparent desk shields for student use at both the middle and elementary schools that will most likely be used during lunchtime as a part of the district's layered mitigation strategy. Similar shields are being used in both Arlington Heights 25 and Oak Grove 68--two districts that D70 has conducted site visits at.

The school board approved the emergency purchase of desks for student use at the elementary level to replace tables to socially distance students as much as possible when elementary school is reopened in full on April 12.

- March 17 will be a Teacher Institute Day, moved from April 5th, with teachers working while **students are off of school and no eSchool Center**;
- April 5 will be a regular attendance day and no longer an Institute Day;
