#### Fiscal Year Education Fund

Mr. John Herrin, District 70's director of finance and operations, presented information on the Education Fund that was recently updated to reflect the approved Individuals with Disabilities Education Act (IDEA) grant funds that the district received from the federal government.

This was done to prepare the school board for the final budget adoption at the Sept. 21 board meeting. Mr. Herrin also provided a brief overview of the budget approval process at the school board meeting. A required part of the budget adoption process is to post the draft budget for review in advance of the meeting. Toward that end, a reopening task force composed of parents, board members, teachers, nurses, and administrators has begun to meet to continue to explore and recommend ways that we can safely reopen our schools for in-person learning. The task force will explore and make recommendations in the following

## areas:

- Reopening metrics;
- Reopening approaches for the elementary schools;
- Reopening approaches for the middle school;
- Reopening health protocols;

The task force will provide an update at the September school board meeting and present final recommendations at the October meeting.

I sincerely hope that you and your family continue to stay well and have a great start to the school year.
